If you want to do your planning online, go to my website. The computer you talk to is me. We can save you money and still get your estate planning done professionally.

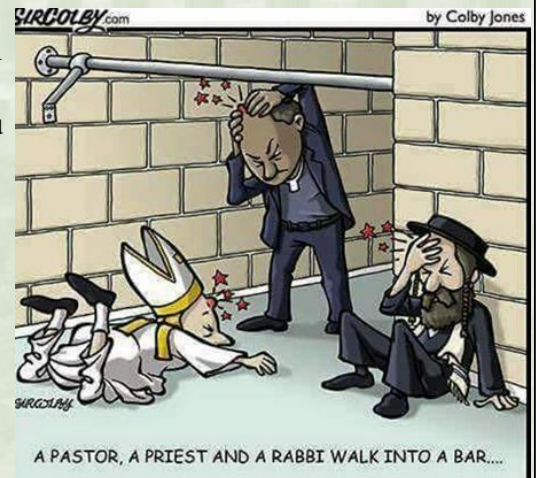
